## ORDER

1. The Principals of affiliated colleges are the admitting authority of students to various courses approved by KTU. They are solely responsible for admitting students as per eligibility.
2. The Principals will have to verify the Certificates/ Documents as per the eligibility criteria which is as in reference cited as 2nd and 3rd above. The eligibility criteria and documents to be verified at the time of admission are as follows:

### a) B.Tech Degree

The **Eligibility Criteria for admission to B.Tech Programme** is mentioned in **Clause 6 Criteria of Eligibility for Admission** in the **Prospectus of KEAM 2015** issued by Government of Kerala and the amendments issued by Government from time to time. All the candidates passed 10+2 class of State Government Boards in India and Overseas boards approved by the Association of Indian Universities (AIU) are eligible for getting admission to B.Tech Courses.

List of documents/certificates to be verified are:

1. 10+2 class Marklist and certificate
2. Transfer and Conduct Certificates
3. Community Certificate (For reservation quota only)
4. Income Certificate (For eligible quota only)



**b) M.Tech Courses**

The **Eligibility Criteria for M.Tech Programme** is mentioned in the Section V of the Prospectus for admission to the P.G. Degree Course in Engineering for the year 2015 and the amendments issued by Government from time to time. Degrees from Universities outside India requires submission of equivalency certificates issued by the AIU.

**The documents/certificates mentioned in section VII of the Prospectus are to be verified.**

3. There is no need to obtain Eligibility/Equivalency/Matriculation Certificates from KTU for admission.
4. Any deviation will be viewed seriously and KTU shall initiate disciplinary proceedings against the Principal including levying fine.
