**ORDER**

The Government vide order read 2<sup>nd</sup> paper above, created various posts in the Non-teaching staff cadre of the APJ Abdul Kalam Technological University and further vide paper read 3<sup>rd</sup>, directed to make appointment to the sanctioned posts of Joint Registrar, Deputy Registrar, Assistant Registrar, Section Officer, Assistant and Clerical Assistant by way of option from the eligible employees working in the other Universities specified in the schedule to the APJ Abdul Kalam Technological University Act, 2015, read 1<sup>st</sup> paper above. The meeting of the Executive Committee of the University held on 30/06/2017, formulated the rules for the appointment of officers by option to the various posts in the Non-teaching staff cadre and authorized the Registrar to expedite the process of appointment.

As such, by the powers conferred by the above read Government orders and Section 7 of the Act, options were invited for making appointment in the above specified categories of Non-teaching staff posts vide circular no KTU/A/333/2016 dt 11/08/2016 from the eligible employees currently working in those Universities specified in the Schedule of the Act . Accordingly, option applications were received and a list of eligible applicants was prepared by the University. Later, vide Letter read 4<sup>th</sup> paper above, the Government directed the University to expedite actions to make appointments by option as per the sanction accorded vide the Government order read 3<sup>rd</sup> paper above.

On the basis of the above orders and rules and exercising the powers conferred by the Act, sanction has been accorded by the Vice Chancellor to appoint the following applicants against the post of Section Officer as detailed in the list below on regular basis by option in the University.
